THE CORPORATION OF THE TOWN OF PARRY SOUND

BY-LAW 2009 - 5318

Being a By-law to repeal By-law No. 94-3705
a By-law to designate 41 Church Street as
being a property of architectural and historical
value.

WHEREAS Section 32 of the Ontario Heritage Act, R.S.O. 1990, Chapter O.18 as amended authorizes the Council of a municipality to repeal a by-law designating a property under Section 29 upon the request of the owner and subject to consultation with the Municipal Heritage Committee and the provision of public notice; and

WHEREAS the owners of 41 Church Street have requested that the By-law passed to designate their property be repealed to address property insurance accessibility issues; and

WHEREAS the Municipal Heritage Committee has been consulted regarding the proposed repeal; and

WHEREAS the Council of the Town of Parry Sound has served upon the owner of the property and upon the Ontario Heritage Trust, notice of intention to repeal the By-law and has published such notice of intention in the local newspaper having general circulation in the municipality in accordance with legislated requirements; and

WHEREAS no notice of objection to the proposed repeal by-law has been served on the Clerk of the Municipality;


NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PARRY SOUND ENACTS AS FOLLOWS:

1. That By-law No. 94-3705 is hereby repealed.
2. The Clerk is hereby authorized and directed to cause a copy of this By-law to be registered against the property in the proper Land Registry Office if necessary.
3. The Clerk is authorized and directed to cause a copy of this By-law to be served upon the owners of the property and upon the Ontario Heritage Trust and to publish notice of the By-law in the local newspaper having general circulation in the municipality.



NOTICE OF PASSING OF A BY-LAW UNDER SECTION 32 OF THE ONTARIO
HERITAGE ACT

TAKE NOTICE that the Council of the Corporation of the Town of Parry Sound passed By-Law No. 2009-5318 on August 10th, 2010 under Section 32 of The Ontario Heritage Act, R.S.O. 1990, c.O.18, as amended;

The purpose of By-Law No. 2009-5318 is to repeal By-law No. 94-3705 which is a By-law designating property known locally as 41 Church Street to be of cultural heritage value or interest. The effect of the By-law is to remove the designation from the property.
