The Corporation of the Village of Bayfield

BY-LAW NO. 182-1982

A By-law to designate an area of the Village of Bayfield as a Heritage Conservation District under Section 41 (1) of The Ontario Heritage Act, 1974, R.S.O. 1980, c. 337 as amended.

WHEREAS Part V of the Ontario Heritage Act contains provisions relating to heritage conservation districts;

AND WHEREAS Council, under Section 40 (1) of the said Ontario Heritage Act, has by by-law defined Main Street, Clan Gregor Square and Elgin Place as an area to be examined for future designation as a heritage conservation district;

AND WHEREAS the examination of Main Street, Clan Gregor Square and Elgin Place has now been completed;

AND WHEREAS under Section 41 of the said Ontario Heritage Act, where there is in effect in a municipality an official plan that contains provisions relating to the establishment of heritage conservation districts, Council may by by-law designate any defined area as a heritage conservation district;

AND WHEREAS there is in effect in the Village of Bayfield an official plan that contains provisions relating to the establishment of heritage conservation districts;

NOW THEREFORE, the Council of the Village of Bayfield ENACTS as follows:

Bayfield, Ontario

April 1, 1991.

I hereby certify this to be a true copy of By-law 182 of 1982, Village of Bayfield,

Clerk.

- 1. The area known locally as Main Street, Clan Gregor Square and Elgin Place, more particularly shown on Schedules "A" and "B" attached hereto, and described on Schedule "C" attached hereto, is hereby designated as a Heritage Conservation District;
- Schedules "A", "B" and "C" are hereby declared to be part of this By-law;
- 3. By-law 167-1982 and By-law 176-1982 of the Corporation of the Village of Bayfield are hereby repealed.
- 4. This By-law comes into effect on the date of passage, subject to receiving the approval of the Ontario Municipal Board.

Read a first and second time this A. day of Alijit, 1982.

Read a third time and finally passed this for day of August, 1982.


