# BY-LAW NUMBER 073-2015

A BY-LAW TO DESIGNATE THE LANDS AND PREMISES KNOWN MUNICIPALLY AS 195 FORTH STREET, IN THE TOWN OF COBOURG, IN THE PROVINCE OF ONTARIO.

WHEREAS section 29 of the Ontario Heritage Act, R.S.O., 1990 c. O.18, as amended, authorizes the council of a municipality to enact a by-law to designate real property including all buildings and structures thereon, to be of cultural heritage value or interest;

AND WHEREAS the Municipal Council of the Corporation of the Town of Cobourg has caused to be served on the owner of the lands and premises PLAN CADDY BLK V LOT 6 PT, LOT 5 and 7 and is known to the municipally as 195 Forth Street and upon the Ontario Heritage Trust, notice of intention to designate the aforesaid real property and has caused such notice of intention to be published in a newspaper of general circulation in the municipality.

AND WHEREAS no notice of objection to the proposed designation has been received;

**AND WHEREAS** this By-law is to be registered in the proper Land Registry Office with respect the property described in Schedule "A" attached hereto:

**NOW THEREFORE** the Municipal Council of the Corporation of the Town of Cobourg enacts as follows:

- THAT the real property PLAN CADDY BLK V LOT 6 PT, LOT 5 and 7 known as 195 Forth Street more particularly described in Schedule "A" hereto is hereby designated as being of cultural value and interest.
- 2. THAT the Municipal Clerk cause a copy of this by-law be served on the owner of the aforesaid property and on the Ontario Heritage Trust and that notice of the passing of this by-law be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks
- THAT this By-law shall come into full force and effect upon the date of its passing

READ a first, second and third time and finally passed in Open Council this 10<sup>th</sup> day of August, 2015.

## SCHEDULE A

#### PROPERTY DESCRIPTION

Town of Cobourg, County of Northumberland, being the whole of PLAN CADDY BLK V LOT 6 PT, LOT 5 and 7 known municipally as 195 Forth Street, Cobourg, ON.

#### STATEMENT OF CULTURAL HERITAGE VALUE OR INTEREST

Constructed between 1882 and 1885 by local carpenter James Fee. The subject property has physical and design value as representative of the Ontario vernacular style from the mid-nineteenth century. Historically, this property has been owned by the Burnet Family who were prominent builders in the community, and Patrick Delanty, former Mayor of Cobourg. Contextually, the subject property is located in the Kerrytown area, a historic Irish settlement.

### DESCRIPTION OF HERITAGE ATTRIBUTES

Key attributes that embody the heritage value of 195 Forth Street as a representative example of the Ontario vernacular style in Cobourg, include its:

- One and a half story mass
- Gabled roof with returning eaves and dormers
- Red brick chimney in stretcher bond on the north facade
- · upper storey windows; two over two, double hung sash
- ower storey windows; twelve over two double hung sash
- stucco cladding (beneath aluminium siding)
- enclosed porch with decorative shingling under eaves
- Doric columns on the dormers (appear to be missing as of 2015)
- putside entrance to the cellar on south side of building
