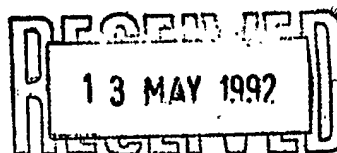

BY-LAW NUMBER 1992-24

A by-law to repeal By-law 1988-74 as to certain lands and to reaffirm as to certain lands

WHEREAS By-law 1988-74 was passed in 1988 designating Lots 122 and 123 as property of historical value.

AND WHEREAS the owner of the land received consent to sever the property into three parcels - two vacant lots and one with the designated building wholly contained on it.

AND WHEREAS the purchasers of the two vacant lots have requested that their land be released from the historical designation.

AND WHEREAS LACAC at their regularly scheduled meeting of December 4, 1991 passed the following motion:


"That the Committee recommend that a by-law be prepared to repeal By-law 1988-74 with reference to Parts 1 and 3 on Plan 20R-9161."

NOW THEREFORE THE COUNCIL ENACTS AS FOLLOWS:


1. By-law 1988-74 is hereby repealed as to the lands described as FIRSTLY in Schedule "A" attached hereto.

2. By-law 1988-74 is hereby confirmed as to the land described as SECONDLY in Schedule "A" attached hereto.
3. Schedule "A" forms part of this by-law.

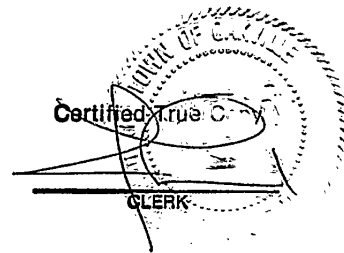

SCHEDULE "A" TO BY-LAW 1992-24

ALL AND SINGULAR that certain parcel or tract of land and premises situate lying and being in the Town of Oakville, Regional Municipality of Halton more particularly described as follows:

FIRSTLY: Those parts of Lots 122 and 123 according to Plan M-8 designated as Parts 1 and 3 on Plan 20R-9161.

SECONDLY: That part of Lot 122 according to Plan M-8 designated as Part 2 on 20R-9161.

Plan M-8 being a plan under the Boundaries Act BA-148.
