RE: KING'S CASTLE

PURSUANT TO Subsection (6) of Section 29 of The Ontario Heritage Act, 1974;

TAKE NOTICE THAT Oakville Town Council, by by-law, on February 6th, 1978, did designate a certain property as a property of historic and architectural value and interest. The by-law is detailed below, together with an explanation of the reasons for the designation:

BY-LAW NUMBER 1978-5

A by-law to designate certain property as property of historic and architectural value and interest (King's Castle).

THE COUNCIL ENACTS AS FOLLOWS:

1. The property commonly known and referred to as King's Castle is hereby designated as a property of historic and architectural value and interest pursuant to The Ontario Heritage Act, 1974.
2. The property designated by this by-law is the property described in Schedule "A" to this by-law.

SCHEDULE "A" to By-law Number 1978-5

ALL AND SINGULAR that certain parcel or tract of land situate, lying and being in the Town of Oakville, in the Regional Municipality of Halton and being composed of Lot 3 according to a plan registered in the Land Registry Office for the Land Registry Division of Halton as No. 1537.

REASONS FOR DESIGNATION

King's Castle is a distinctively styled Brick Gothic House, with tall narrow gables and a steeply pitched roof. It was built in 1854 by William MacKenzie King, who, after the death of his parents was raised as ward, by the founder of Oakville, William Chisholm. William M. King also established Oakville's first reformed newspaper, "The Oakville Advertiser".
