RE: PALERMO UNITED CHURCH

PURSUANT TO Subsection (6) of Section 29 of The Ontario Heritage Act, 1974;

TAKE NOTICE THAT Oakville Town Council, by by-law, on May 2nd, 1978, did designate a certain property as a property of historic and architectural value and interest. The by-law is detailed below, together with an explanation of the reasons for the designation:

THE CORPORATION OF THE TOWN OF OAKVILLE BY-LAW NUMBER 1978-38

A by-law to designate certain property as property of historic and architectural value and interest (Palermo United Church).

THE COUNCIL ENACTS AS FOLLOWS:

- 1. The property commonly known and referred to as the Palermo United Church is hereby designated as a property of historic and architectural value and interest pursuant to The Ontario Heritage Act, 1974.
- 2. The property designated by this by-law is the property described in Schedule "A" to this by-law.

SCHEDULE "A" to By-law Number 1978-38

ALL AND SINGULAR that certain tract or parcel of land situate in the said Town of Oakville, Regional Municipality of Halton, Province of Ontario containing by admeasurement fifty-four feet (54') front by one hundred and ten feet (110') back be the same more or less, which said tract or parcel of land is butted and bounded, or may be otherwise known as follows that is to say:

GOMMENCING one hundred and thirty-two feet (132') from the southerly angle of lot number 30 in the First Concession north of Dundas Street, formerly in the Township of Trafalgar, County of Halton and Province aforesaid, THENCE north 38 degrees east, fifty-four feet,

THENCE north 45 degrees west, one hundred and ten feet,

THENCE south 38 degrees west, fifty-four feet,

THENCE south 45 degrees east, one hundred and ten feet, to the place of beginning.

Save and except those lands expropriated by the Province of Ontario by Highway Plan registered in the Land Registry Office for the Land Registry Division of Halton on the 9th day of July, 1971 as number 1482 and designated as Part 2 on the said plan.

REASONS FOR DESIGNATION

Palermo United Church is a well preserved example of a Gothic style country Church, built of brick, with heavy buttresses, and with characteristic pointed arch door and window openings. The structure was planned and built by local members of the congregation in 1867, in Hagartown, later known as the Village of Palermo.
