NOTICE OF PASSING OF BY-LAW NO. 31-92

TAKE NOTICE that the Council of the Corporation of the Town of Aylmer, at its meeting on May 11, 1992 enacted By-law No. 31-92, being a By-law to repeal By-law No. 3-92, being a by-law to amend By-law No. 2-86, being a By-law to designate the property described as comprising of the West Part of Lot 12, Registered Plan 164, known municipally as 199 Talbot Street West, in the Town of Aylmer, commonly referred to as Maplehurst, as being of architectural and historical value or interest, in accordance with Part IV of the Ontario Heritage Act, R.S.O. 1980, Chapter 337.

By-law No. 31-92 was passed as the owners of 199 Talbot Street West, have learned that the foundations for the remainder of the building has deteriorated beyond repair, and have, therefore, requested that the balance of the real property, including all buildings thereon, be removed from the heritage designation.

BY-LAW NO. 31-92

OF THE CORPORATION OF THE TOWN OF AYLMER

Being a By-Law to repeal By-Law No. 3-92, being a by-law to amend By-Law No. 2-86, being a By-Law to designate 199 Talbot Street West, Maplehurst, as being of architectural and historical value or interest.

WHEREAS, Section 32 of The Ontario Heritage Act, R.S.O. 1990, Chapter 337, authorizes the Council of a municipality to repeal by-laws, which designates real property, including all buildings thereon, to be of architectural or historical value or interest.

AND WHEREAS, By-Law No. 3-92, passed on January 13, 1992, authorized that a portion of the real property at 199 Talbot Street West, be removed from the heritage designation;


AND WHEREAS, The owners of 199 Talbot Street West, have learned that the foundations for the remainder of the building has deteriorated beyond repair, and have, therefore, requested that the balance of the real property, including all buildings thereon, be removed from the heritage designation;

NOW THEREFORE, THE COUNCIL OF THE CORPORATION OF THE TOWN OF AYLMER HEREBY ENACTS AS FOLLOWS:


1. That the Municipal Solicitor be authorized to cause a copy of this By-Law to be registered against the property described in Schedule "A", By-Law 2-86, in the Land Registry Office for the County of Elgin.
2. The Clerk is hereby authorized to cause a copy of this By-Law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation, and to ~~cause notice of the passing of this By-Law to be published in a newspaper having general circulation in the Town of Aylmer, for each of three consecutive weeks.~~
3. That By-Law Nos. 3-92 and 2-86, are hereby repealed.


