NOTICE OF INTENTION TO DESIGNATE

On May 26, Oakville Town Council resolved to pass a Notice of Intention to Designate the following property under Section 29 of the *Ontario Heritage Act*, R.S.O. 1990, c. O.18, as amended, as a property of cultural heritage value and interest:

Description of Property

The Oakville Arena is located on the north side of Rebecca Street between Felan Avenue and Kerr Street on the southern edge of Trafalgar Park in Oakville. The park includes the mid-20th century arena building, as well as other elements including public open space, tennis courts, a playground, basketball court, softball diamond and swimming pool.

Statement of Cultural Heritage Value or Interest

The Oakville Arena has physical and design value as a c.1951 arena complex designed by William Armstrong, an Oakville architect. Normal Hipel led construction and designed its Hipel truss roof, a simple and economic roof system for spanning large spaces like arenas. This roof, which gives the arena its distinctive character, is one of only four known surviving Hipel roof systems in Ontario arenas.

The building has historical and associative value for its association with Norman Hipel and with the many sporting, recreational, and social events held at the arena throughout its life as the central community centre in Oakville. The arena was home to the Oakville Blades for more than two decades and was the home arena for Otto and Maria Jelinek, World Champion pairs figure skaters. The history of sports, recreational, and social events gives this arena emotive and symbolic value.

The arena also has contextual value because it is physically, functionally, visually, and historically linked to its immediate setting. The arena maintains and supports the character of the park and surrounding area in scale, orientation, and function.
