NOTICE OF HERITAGE DESIGNATION

On January 12, 2015, Oakville Town Council resolved to pass By-law 2015-004 to designate the following property under Section 29 of the *Ontario Heritage Act*, R.S.O. 1990, c. O.18, as amended, as a property of cultural heritage value and interest:

Hiram Smith Farmhouse 457 Smith Lane Part of Lot 12, Plan 956, designated as Part 2 on Plan 20R-20016 Town of Oakville, Regional Municipality of Halton

Cultural Heritage Value and Interest:

The Hiram Smith Farmhouse is located on the east side of Smith Lane. This 1-1/2 storey painted brick farmhouse is surrounded by a 1960s residential subdivision. The farmhouse faces south, which is now the side yard of the property.

Design Value or Physical Value

The Hiram Smith Farmhouse has physical value as a representative example of a mid-19th century Ontario Gothic farmhouse. The original 1-1/2 storey portion of the house likely dates to circa 1860 and was constructed with handmade local brick. The one storey rear addition was built circa 1890 and also contributes to the physical value of the farmhouse.

Historical Value or Associative Value

The Hiram Smith Farmhouse has historic value through its associations with the Smith family of Trafalgar Township, who in turn have direct associations with the Rebellion of 1837 and the historic theme of Oakville's agricultural development.

The first owner of the property, Hiram Smith, was a militia volunteer for a Loyalist troop during the Rebellion of 1837. - the 6/6 wood sash windows on the east elevation

BY-LAW NUMBER 2015-004

A by-law to designate the Hiram Smith Farmhouse at 457 Smith Lane as a property of historical, architectural and contextual significance.

WHEREAS pursuant to Part IV of the *Ontario Heritage Act*, R.S.O. 1990, chapter O.18, the council of a municipality is authorized to enact by-laws to designate a real property, including all buildings and structures thereon, to be of cultural heritage value or interest;

WHEREAS the council of the Corporation of the Town of Oakville has caused to be served on the owners of the lands and premises at:

457 Smith Lane Oakville, ON

and upon the Ontario Heritage Trust, notice of intention to designate the Hiram Smith Farmhouse at 457 Smith Lane as a property of historical, architectural and contextual significance and a statement of the reasons for the proposed designation, and further, has caused the notice of intention to be published in the Oakville Beaver, being a newspaper of general circulation in the municipality;

AND WHEREAS no notice of objection to the proposed designation has been served on the municipality;

COUNCIL ENACTS AS FOLLOWS:

1. That the following real property, more particularly described in Schedule "A", is hereby designated as being of cultural heritage value or interest, for the reasons set out in Schedule B:

457 Smith Lane
Town of Oakville
The Regional Municipality of Halton



- 2. That the attached Schedules form part of the by-law.
- 3. And that the Town Solicitor be authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" at the Land Registry Office.
