BY-LAW NO. 3375 (2013)

Being a by-law to designate the Fenwick Flag Pole

WHEREAS pursuant to Part IV of the Ontario Heritage Act, R.S.O., 1990, the Council of a municipality is authorized to enact by-laws to designate a real property, including buildings and structures thereon, to be of cultural heritage value or interest.

WHEREAS the municipal council of the Corporation of the Town of Pelham has cause to be served on the owner (The Corporation) of the lands and premises at:

*Part of the Original Road Allowance between Lots 15 & 16,
Concession 9, Former Township of Pelham, Now in the Town of Pelham
Regional Municipality of Niagara
(Intersection of Canboro Road and Maple Street)*

and upon the Ontario Heritage Trust, notice of intention to designate the Fenwick Flag Pole and a statement of the reasons for the proposed designation, and further, has caused said notice of intention to be published in the Welland Tribune, being a newspaper of general circulation in the municipality;

AND WHEREAS no objections to the proposed designation have been received;

AND WHEREAS the reasons for designation and extent to which the designation applies are set out in Schedule "B" attached hereto and form part of this By-law.


COUNCIL ENACTS AS FOLLOWS:

1. THAT the following real property, more particular described in Schedule "A" attached hereto and forming part of this By-law is hereby designated as being of cultural heritage value or interest:

2. THAT the Town solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule "A" attached hereto at the Land Registry Office.

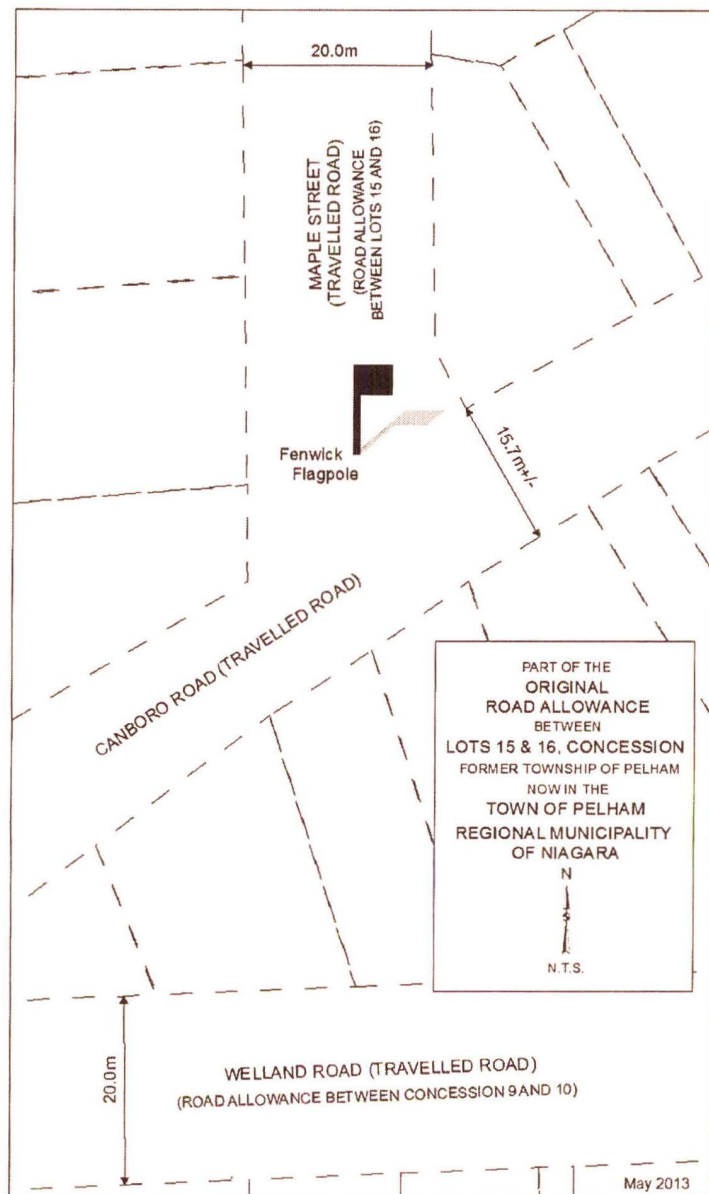

Concession 9, Former Township of Pelham, Now in the Town of Pelham

(Intersection of Canboro Road and Maple Street)*



**SCHEDULE B TO
BY-LAW 3375 (2013)
STATEMENT OF SIGNIFICANCE**

The Fenwick Flag Pole is of historical/associate value because of its significance to the community. It was moved from E.W. Farr School (SS#9) to the center of the village of Fenwick at the intersection of Canboro Road and Maple Street, in 1929. At this time a siren was mounted on the pole to warn residents of fire and also should the need to rally or evacuate be present. During the next few decades it donned a sign on the flag staff that said "Welcome to Fenwick". Monumental events, such as the return of veterans from the Second World War were celebrated around the flag pole. The flag pole is of contextual value because as the nucleus of the Fenwick community it is important to defining the character of the area and is a major point of reference. The Flag Pole is a rare and unique example of a metal multi-legged flagpole. Key attributes that support its cultural heritage value include its location in the intersection, its steel and aluminum construction, weathered galvanized colour, revolving top with 6" ball and a halyard system.
