NOTICE OF INTENTION TO REPEAL DESIGNATING BY-LAW

TAKE NOTICE that the Council of the Corporation of the City of Pembroke intends to repeal the by-law designating the property including lands and buildings, at the following municipal address as a property of architectural and historical value or interest under Part IV of the Ontario Heritage Act, 1974, S.O. Chapter 122.

REASONS FOR PROPOSED REPEAL OF DESIGNATING BY-LAW

To restore the Pembroke Public School to its former glory would require the replacement of the pitched gabled roofs and bell tower, the repointing of the masonry, the redesign of the interior, the removal of the 1948 addition and the replacement of windows and doors.

As this work would cost many thousands of dollars and there may be no committed users it is proposed the designating by-law be repealed.

Any person may, within thirty days of the first day of August, 1992, send by registered mail or deliver to the Chief Administrative Officer of the Corporation of the City of Pembroke, notice of his or her objection to the proposed repeal of designated by-law together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the City of Pembroke shall refer the matter to the Conservation Review Board for a hearing.
