BY-LAW NUMBER 10849

A BY-LAW TO REPEAL BY-LAW NUMBER 10771 WHICH IS A BY-LAW TO DESIGNATE A BUILDING AT 397 - 399 FRONT STREET WITHIN THE CITY OF BELLEVILLE TO BE OF HISTORIC OR ARCHITECTURAL VALUE OR INTEREST (KNIGHTS OF COLUMBUS HALL)

WHEREAS By-Law 10771 being a By-law to designate a building at 397 - 399 Front Street within the City of Belleville to be of historic or architectural value or interest (Knights of Columbus Hall) was duly passed by the Council of the City of Belleville on the 14th day of January, 1980;

AND WHEREAS an application has now been received from the Columbus Club Inc. requesting that the said By-Law 10771 be repealed;

AND WHEREAS the Local Architectural Conservatory Advisory Committee has been consulted in accordance with Section 32 (2) of the Ontario Heritage Act 1974 and the said Committee has indicated that it will not object to the repeal of By-Law 10771:


NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF BELLEVILLE ENACTS AS FOLLOWS:

1. THAT By-Law Number 10771 being a by-law to designate a building at 397 - 399 Front Street within the City of Belleville to be of historic or architectural value or interest (Knights of Columbus Hall) be and is hereby repealed.
2. THIS BY-LAW SHALL COME INTO FORCE AND TAKE EFFECT IMMEDIATELY ON AND AFTER THE PASSING THEREOF.

Read a second time this 21st day of July, 1980.


Read a third time and finally passed this 21st day of July, 1980.
