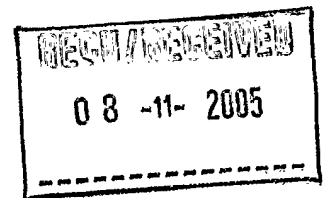

THE CORPORATION OF THE CITY OF PEMBROKE

BY-LAW 2005 – 57

A BY-LAW TO REPEAL BY-LAW 82-58 OF THE CORPORATION OF  
THE CITY OF PEMBROKE, BEING A BY-LAW TO DESIGNATE THE  
PROPERTY MUNICIPALLY KNOWN AS 253 CATHERINE STREET  
AS BEING OF CULTURAL HERITAGE VALUE OR INTEREST

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, authorizes the Council of a municipality to enact by-laws to designate a property within the municipality to be of cultural heritage value or interest;

AND WHEREAS Section 31 and 32 of The Ontario Heritage Act, R.S.O. 1990, Chapter 0.18, allows the Council of a municipality to repeal a by-law or part thereof designating property;


AND WHEREAS the Council of the Corporation of the City of Pembroke has caused to be served on the owners of the lands and premises municipally known as 253 Catherine Street and more particularly described as Lots 164 and 165, Plan 36; City of Pembroke and being all lands within PIN #57158-0055 (LT), and upon the Ontario Heritage Trust Notice of Intention to repeal a designating By-law on the aforesaid real property and has caused such Notice of Intention to Repeal a Designating By-law to be published in a newspaper having general circulation in the municipality;


AND WHEREAS no notice of objection to the proposed intention to repeal a designating by-law has been served on the Chief Administrative Officer of the municipality;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF PEMBROKE ENACTS AS FOLLOWS:

1. That By-law 82-58 be, and is hereby amended by deleting therefrom Section 1 (a), which now deletes any reference to 253 Catherine Street as being a designated building under the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18.
2. The Manager of Planning and Building is hereby authorized to cause a copy of this by-law to be registered against the property in the proper land registry office.
3. The Chief Administrative Officer is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Trust and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the municipality.
4. By-law 82-58 shall be repealed in its entirety. By-law 98-40 deleted any reference to 48 Renfrew Street as being a designated building under the Ontario Heritage Act, R.S.O. 1990, Chapter 0.18.
5. This By-law shall come into force and take effect upon the date of the final passing thereof.


