



## NOTICE OF INTENTION TO REPEAL A DESIGNATING BY-LAW

TAKE NOTICE that the Council of the Corporation of the City of Pembroke intends to repeal By-lay 82-58 which designates the following property:

253 Catherine Street Lots 164 & 165, Plan 36; City of Pembroke and being all lands within PIN #57158-0055 (LT)

## Reason for Proposed De-designation

The designation of 253 Catherine Street was proposed for architectural and historical reasons.

The reason for Council's intention to repeal the designating by-law, at the owner's request, is the cost of restoring the building to its original condition and the limitations imposed for alterations to the building.

Any person may before the 18<sup>th</sup> of October, 2005, send by registered mail or deliver to the Chief Administrative Officer, notice of his or her objection to the intention to repeal Designating By-law 82-58 together with a statement of the reasons for the objection and all relevant facts. When a Notice of Objection has been received, Council will refer the matter to the Conservation Review Board for a hearing and report.
