THE CORPORATION OF THE TOWN OF

PENETANGUISHENE

BY-LAW NO. 1985-72

A by-law to designate the property known municipally as "The Penetanguishene Angels" as being of architectural and/or historical value or interest.

WHEREAS section 29 of the Ontario Heritage Act, R.S.O. 1980, Chapter 337 authorizes the Council of a municipality to enact by-laws to designate real property, including all buildings and structures thereon, to be of architectural or historical value and interest;

AND WHEREAS the Council of the Corporation of the Town of Penetanguishene has caused to be served on the owners of the lands and premises known as "The Penetanguishene Angels" Main Street and upon the Ontario Heritage Foundation, Notice of Intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks;

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality;

THEREFORE the Council of the Corporation of the Town of Penetanguishene enacts as follows:

1. There is designated as being of architectural and/or historical value or interest the real property known as "The Penetanguishene Angels" Main Street more particularly described as Parts 1, 2 and 3 in Registered Plan 51R-13786 in the Town of Penetanguishene, County of Simcoe in the Province of Ontario.
2. The municipal solicitor is hereby authorized to cause a copy of this by-law, and the reasons for designation, to be registered against the property described above, in the proper land registry office.
3. The Clerk is hereby authorized to cause a copy of this by-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this by-law to be published in a newspaper having general circulation in the municipality once for each of three consecutive weeks.

By-law read a first, second and third time and finally passed in open Council on the 28th day of October, 1985.
