NOTICE OF A REPEAL TO A HERITAGE DESIGNATION

TAKE NOTICE THAT THE MUNICIPAL COUNCIL  
OF THE TOWN OF PERTH  
AT THEIR REGULAR MEETING ON FEBRUARY 14, 1989,  
ADOPTED THE FOLLOWING BY-LAW

CORPORATION OF THE TOWN OF PERTH  
BY-LAW NO. 2809

Being a by-law to repeal the heritage designation on a certain property within the Town of Perth which is not of historical or architectural value or interest.

WHEREAS Chapter 337 of The Ontario Heritage Act, R.S.O. 1980 provides that the Municipality may, by by-law, repeal the heritage designation on a property within the Municipality to be of historical or architectural value or interest.

AND WHEREAS notice of intention to repeal the heritage designation on a certain property within Perth was served on the owner of the property and The Ontario Heritage Foundation on December 15, 1988 and was published in The Perth Courier December 21, 1988, December 29, 1988 and January 4, 1989.

AND WHEREAS no objections were received against the repealing of the said property as a result of the aforementioned notices.

NOW, THEREFORE, THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF PERTH ENACTS AS FOLLOWS:

- (i) By-Law No. 2809 for the vacant property shown as Part 2, Plan 27R2848 and Part 4, Plan 27R2825.

The above By-Law Numbered 2809 shall come into force and take effect on the passage thereof.

A By-Law To Repeal The Heritage Designation On  
A Certain Property Within The Municipality Which Is  
Not Of Historic Or Architectural Value Or Interest

WHEREAS Chapter 337 of The Ontario Heritage Act, R.S.O. 1980 provides that the Council of a Municipality may, by by-law, repeal the heritage designation on a property within the Municipality to be of historical or architectural value or interest.

AND WHEREAS notice of intention to repeal the heritage designation on a certain property within the Municipality was served on the owner of the property and The Ontario Heritage Foundation December 15, 1988 and was published in The Perth Courier December 21, 1988, December 29, 1988 and January 4, 1989.

AND WHEREAS no objections were received against the repealing of the said property as a result of the aforementioned notices;

NOW THEREFORE, the Municipal Council of The Corporation of the Town of Perth ENACTS AS FOLLOWS:

1. The by-law designating the following property be and is hereby repealed.


Description: The vacant land located on Lot Number 8 on Cockburn Island and Lot Number 9 on the North Side of Colborne Street, Plan 8828 and more particularly described as Part 2, Plan 27R2848 and Part 4, Plan 27R2825.


Owner: The Corporation of the Town of Perth.

Reason for Repealing the Designation: The original By-Law No. 2458 designating this property was registered against the building and the vacant land. The Town sold the building, which is designated, and kept the vacant land. The Town would not like to repeal the designation on the vacant land.


2. This by-law shall come into force and take effect on the passing thereof.
