

Description: The property at 11-13-15 Mill Street, Perth, Ontario.




REASON FOR DESIGNATION:

This woodframe house of early victorian architecture was constructed in 1846 and first owned by the Tay Navigational Company.


This by-law shall come into force and take effect on the passing thereof.
