



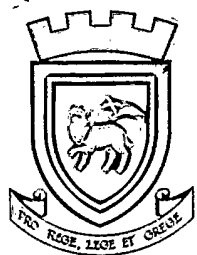

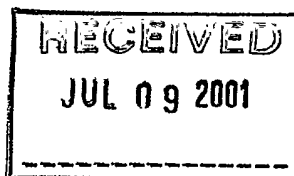



NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Perth intends to designate the following property as property being of architectural and historical value or interest under Part IV of the Ontario Heritage Act, RSO 1990, Chapter 0.18:

13 Gore Street West
Perth, Ontario
(the former Perth Public Utilities Office)

THE PURPOSE of this designation is to recognize the heritage significance of the structure. Built during the 1880's, this building represents a valuable piece of the heritage infrastructure for our community, and has been recommended for designation by the Town's Local Architectural Conservation Advisory Committee. Further details on the buildings history are available in the Clerk's office at Town Hall.

ANY PERSON may, within 30 days of the first publication of this notice send by registered mail, or deliver to the Clerk of the Town of Perth, notice of his or her objection to the proposed designation together with a statement of the reasons for the objection and all relevant facts. If such notice of objection is received, the Council of the Corporation of the Town of Perth shall refer the matter to the Conservation Review Board for a hearing.
