IN THE MATTER OF THE ONTARIO HERITAGE ACT, 1974 5.O. CHAPTER 122 AND IN THE MATTER OF THE LANDS AND PREMISES AT THE FOLLOWING MUNICIPAL ADDRESS IN THE PROVINCE OF ONTARIO

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Town of Wingham intends to designate the property, including lands and buildings of the following municipal address as a property of both architectural and historical value or interest under Part IV of The Ontario Heritage Act, 1974, S.O. Chapter 122.

The Building known as "The Old Post Office", 273 Josephine Street, Wingham, Ontario.

The building known colloquially as "The Old Post Office" is recommended for designation for architecture. tural reasons as an example of public design of the Town-of-the-century era. Historically, the building has served as a Post Office and originally a Customs Office

from its openings in 1907 until 1968 when it was deeded to the town.

Any person may, within shirty days of the first publication of thic notice, send by registered mall or deliver to the Clerk of the Town of Wingham notice of his or her objection to the proposed designation together with, a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Town of Wingham shall-refer the matter to the Conservation Review Board for a hearing.
