and buildings at the following Municipal addresses as properties  
of architectural and/or historical value or interest under Part IV  
of the Ontario Heritage Act, 1974, R.S.O., 1980, Chapter 337.

Municipal Address - 302 Centre Street, Wingham

### Reasons for the Proposed Designation

Built in 1889, the house is one of the best preserved  
examples of the decorative combination of brick and wooden design  
and construction in its period.

Municipal Address - 79 Victoria Street West, Wingham

Reasons for the Proposed Designation

The cast iron fence on this property is the best known example of the artistic architectural iron work produced in Wingham's first iron foundry.

Municipal Address - 88 Patrick Street West, Wingham

Reasons for the Proposed Designation

Built in 1873, the house is one of the earliest and best examples of the use of a tower as a design element in frame construction.

Municipal Address - 63 Albert Street East, Wingham

Reasons for the Proposed Designation

Built in 1883, the house is one of the best preserved examples of double balloon frame construction, clad with double tongue and groove, graduated pine siding.


Municipal Address - 104 Patrick Street East, Wingham

Reasons for the Proposed Designation

Built about 1883, the house is one of the best examples of residential construction of locally made brick, combined with elaborate gable decoration of fretwork pine barge board.

Notice of objection to any of the proposed designations, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the Town of Wingham, before the 7th day of November, 1983.
