THE CORPORATION OF THE TOWN OF WINGHAM BY-LAW NO. 1833(1986)

By-law to designate 130 John Street East in the Town of Wingham.

WHEREAS Section 29 of the Ontairo Heritage Act, R.S.O., 1980, Chapter 337, authorizes Council of a Municipality to designate property within the Municipality to be of historic value or interest;

AND WHEREAS the Clerk of the Town of Wingham has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of The Ontario Heritage Act, R.S.O., Chapter 337.

NOW THEREFORE, the Municipal Council of the Corporation of the Town of Wingham enacts as follows:

- 1. The property described in Schedule "A" attached hereto, is hereby designated to be of historic and architectural value and interest.
- The Municipal Solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described above in the proper Land Registry Office.
- The Clerk is hereby authorized to cause a copy of this By-law to be served on The Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the Municipality once for each of three consecutive weeks.
- 4. This By-law shall come into effect on the final passing thereof by the Council of the Corporation of the Town of Wingham.

SCHEDULE "A"

All and Singular that certain parcel of land and premises situate lying and being in the Town of Wingham, in the County of Huron and being composed of that part of Lot 83, Plan 418, more particularly described as follows:

COMMENCING at the Northeast angle of said Lot;

THENCE Southerly along the easterly limit of the said Lot 21.87 feet to a point, which point is the point of commencement of the lands herein conveyed.

THENCE Westerly parallel to the northerly limit of said lot 65 feet to a point;

THENCE Southerly perpendicular to the northerly limit of said lot 88.35 feet to a point;

THENCE Easterly parallel to the northerly limit of the said lot 65 feet to a point in the easterly limit of the said lot;

THENCE Northerly along the easterly limit of the said lot 88.35 feet to the point of commencement, as described in Instrument No. 220851.
