NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE THAT the Council of the Corporation of the Township of Lobo intends to designate the property, including lands and buildings, at the following location as a property of architectural value or interest under Part IV of The Ontario Heritage Act, R.S.O., 1980-

a) Location: Melville United Church
Part Lot 12, Concession 8
Township of Lobo

The attached key map indicates the location of the subject property in this rural municipality situated in Middlesex County west of the City of London.

b) Reasons for Designation:

Melville United Church, built in 1886 is recommended for designation by reason of the unique construction of the steeple, the exterior focus of the church. Other signifigant features are the original stain glass windows and original "snake" design slate roof.
