NOTICE OF INTENTION TO DESIGNATE

NOTICE is hereby given that the Council of the Corporation of the City of Nanticoke intends to designate the property lying between Harbour Street and the Lynn River (being the Port Dover Harbour), being Plan 207, part of St. Andrew Street between Railway Lots 7 and 8, having a frontage of 66 feet, former Town of Port Dover, now in the City of Nanticoke, Region of Haldimand-Norfolk, pursuant to The Heritage Act, S.O. 1974, as amended.

The building thereon known locally as "MacDonald's Net Shanty" is deemed to be of historic value and interest being a typical example and one of the few remaining fishermen's shanties of the 1920 era on the north shore of Lake Erie. It is a two story frame building constructed of clapboard siding with gable ends, a brick chimney and asphalt 3-in-1 shingles. There are two double hung framed windows on the lower northeast side of the building; one wooden framed entrance door and two double hung framed windows on the lower part and two double hung framed windows on the upper part of the northwest end; four hinged hung framed windows on the upper part and four double hung framed windows on the lower part of the southwest side; and one double hung framed window and one six foot, wooden, inside, sliding door on both upper and lower parts of the southeast end.

NOTICE of objection to the designation of said property shall be served on the Clerk setting out the reason for objection and all relevant facts within thirty (30) days of the date of this publication of Notice of Intention.
