Dear Sir/Madam:

Please consider this as a Notice of Intention to pass a By-law to designate property within the Township of Madoc to be of historical or architectural value or interest pursuant to the Ontario Heritage Act.

The Council of the Township of Madoc proposes to designate five buildings on the O'Hara Mill Conservation Area site as buildings of architectural or historic significance under the Ontario Heritage Act. These buildings are:

1) House; 2) Carpenter shop; 3) Mill; 4) Large barn; 5) Small barn

all of which are located in the Township of Madoc, in the County of Hastings and being composed of part of Lot 6, in the third Concession of the said Township, more particularly described as follows:

Commencing at a point distant two hundred and eighty-five feet measured on a course of north ten degrees sixteen minutes west from a point in the southerly limit of said Lot 6 distant six hundred and ninety-three feet measured westerly thereon from the south east angle thereof; thence north ten degrees sixteen minutes west two hundred and seven feet; thence south eighty-eight degrees eleven minutes west one hundred and twenty feet; thence south one degree fifty-three minutes east one hundred and eighty-one and five-tenths feet; thence south eighty-three degrees six minutes east one hundred and fifty-two feet more or less to the place of beginning.

The buildings to be designated are on the site of the first white settlers of Madoc Township and are constructed typically of nineteenth century buildings and are in more or less original condition. The Mill contains a rare type of saw found infrequently in Ontario.

Anyone wishing to object to the designation of these buildings may do so within thirty days of the publication of this notice by serving upon the Clerk of the Township of Madoc, a notice of objection setting out the reason for the objection and all relevant facts.

The notice is to be published in the Madoc Review newspaper beginning March 21, 1984.
