

**BY-LAW NUMBER 54-03  
OF  
THE CORPORATION OF THE MUNICIPALITY OF MEAFORD**

---

**Being a By-law to rescind By-law 1989-17 passed the 6<sup>th</sup> day of June, 1989  
by the former Township of Sydenham  
Regarding a Historical designation of the Woodford Hotel**

**WHEREAS** the Corporation of the Township of Sydenham passed By-law 1989-17 on the 6<sup>th</sup> day of June, 1989, to designate the Woodford Hotel as being of architectural and historical value or interest;

**AND WHEREAS** Section 28(g) of the Interpretation Act, c.l.11, R.S.O. 1990 and amendments thereto enables the Councils of Municipalities to revoke by-laws;

**AND WHEREAS** a Restructuring Order effective the 1<sup>st</sup> day of January, 2001 amalgamated the Township of Sydenham, the Township of St. Vincent and the Town of Meaford as the Corporation of the Municipality of Meaford;

**AND WHEREAS** Council of the Corporation of the Municipality of Meaford deems it expedient to rescind By-law 1989-17;

**AND WHEREAS** further to Section 31 of the Ontario Heritage Act, R.S.O. 1990, c.O.18, Notice of the intent to rescind By-law 1989-17 was published in a local newspaper and Notice was forwarded to the Ontario Heritage Foundation;

**AND WHEREAS** no objection has been received regarding the rescinding of the designation;

**NOW THEREFORE** Council of the Corporation of the Municipality of Meaford hereby enacts as follows:

1. By-law No. 1989-17, of the former Township of Sydenham, is hereby rescinded.
2. That this By-law shall come into force and take effect upon receiving the final passing thereof.
