

To designate the north building of Lisgar Collegiate, at 29 Lisgar Street, in the City of Ottawa of architectural and historical value.

Whereas The Ontario Heritage Act, 1974, authorizes the Council of a municipality to enact by-laws to designate real property, including all the buildings and structures thereon, to be of historic or architectural value or interest; and

Whereas the Council of The Corporation of the City of Ottawa has caused to be served upon the owner of the lands and premises known as the north building of Lisgar Collegiate, at 29 Lisgar Street, and upon the Ontario Heritage Foundation notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in a newspaper having a general circulation in the municipality once for each of three consecutive weeks; and

Whereas the reasons for the designation are set out as Schedule "B" hereto; and

Whereas no notice of objection to the said proposed designation has been served upon the clerk of the municipality;

Therefore, the Council of The Corporation of the City of Ottawa enacts as follows:


1. There is designated as being of architectural and historical value or interest the real property, more particularly described in Schedule "A" hereto, known as the north building of Lisgar Collegiate, 29 Lisgar Street.

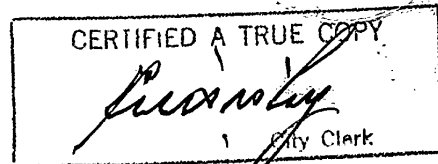
2. The City Solicitor is hereby authorized to cause a copy of this by-law to be registered against the property described in Schedule "A" hereto in the proper land registry office.

3. The City Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the aforesaid property and upon the Ontario Heritage Foundation and to cause notice of this by-law to be published in a newspaper having general circulation in the City of Ottawa.

SCHEDULE "A"

ALL AND SINGULAR that certain parcel or tract of land
and premises situate, lying and being in the City of Ottawa,
in the Regional Municipality of Ottawa-Carleton and Province
of Ontario and
BEING COMPOSED of part of Lot "D", Concession "C", Rideau Front,
Township of Nepean, now City of Ottawa, and being designated
as Parts 9, 10, 11, 12 and 13 according to a plan received
and deposited in the Land Registry Division of Ottawa (No. 4)
as Plan 4R-1008.

SCHEDULE "B"

Reasons for the designation of the north building of Lisgar Collegiate, 29 Lisgar Street.

The north building of Lisgar Collegiate Institute is designated for architectural and historical interest. The original centre section was first erected in 1872 and opened in 1874. The building is a significant Victorian architectural feature in the Central Area of the City of Ottawa. The Institute has particular historical significance as a widely recognized educational facility.
