Notice of Intention to Designate 13-15 Inglewood Drive, Hamilton

WHAT: In the matter of the Ontario Heritage Act and the property in the City of Hamilton known municipally as 13-15 Inglewood Drive, notice is hereby given that the City of Hamilton intends to designate this property as being a property of cultural heritage value.

WHY: The dwelling at 13-15 Inglewood Drive was constructed in the mid 19th century in the Gothic Revival architectural style. It was constructed for Archibald Kerr who became a prominent local business man that left a mark on Hamilton. The property is also associated with a number of other prominent locals such as John Stuart who was involved in the railway and William Thomas, the architect who designed the dwelling. The Statement of Cultural Heritage Value reflects cultural heritage attributes on the exterior, interior and landscape of the property.

The Statement of Cultural Heritage Value or Interest, Description of Heritage Attributes and supporting Cultural Heritage Assessment may be found online via www.hamilton.ca or viewed at the Office of the City Clerk, 71 Main Street West, 1st Floor, Hamilton, Ontario, during regular business hours.

HOW & WHY: Any person may, within 30 days after the date of the publication of the Notice, serve written notice of their objections to the proposed designation, together with a statement for the objection and relevant facts.


