CORPORATION OF THE TOWNSHIP OF CUMBERLAND BY-LAW NUMBER 70-94

A BY-LAW TO AMEND THE DESIGNATING 65-84 FOR PART OF THE PROPERTY KNOWN MUNICIPALLY AS THE CUMBERLAND TOWNSHIP HERITAGE MUSEUM BEING OF ARCHITECTURAL AND/OR HISTORICAL VALUE OR INTEREST.

WHEREAS the Council of the Corporation of the Township of Cumberland designated the real property known as the Cumberland Township Heritage Museum being Part of Lot 11, Concession 1, Old Survey, and including all buildings and structures thereon to be of .architectural or historical value or interest under Section 29 of The Ontario Heritage Act, R.S.O. 1990, Chapter 0.18; and,

WHEREAS the Council of the Corporation of the Township of Cumberland has caused to be served upon the Ontario Heritage Foundation, notice of intention to amend the designating By-law 65-84 for the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks; and,

WHEREAS the Conservation Review Board has held a hearing to determine whether the by-law designating the property in question should be amended and reported its findings of fact and recommendations to the Council; and,

WHEREAS the Council has considered the report of the Conservation Review Board;

THEREFORE the Council of the Corporation of the Township of Cumberland enacts as follows:

- The real property known as the Cumberland Township Heritage Museum and described as Part 1 on Reference Plan 4R-8588 shall be deleted from the lands designated by Bylaw 65-84 Registered in the Registry Division of Russell No. 50 as Instrument No. 91014 on September 10, 1984, and more particularly described in Schedule A hereto.
- The municipal solicitor is hereby authorized to cause a copy of this By-law to be registered against the above mentioned property in the proper land registry office.
- The Clerk is hereby authorized to cause a copy of this by-law to be served on the Ontario Heritage Foundation and to cause notice of passing of this by-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.
