NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the City of Nepean intends to designate the properties, including lands and buildings, at the following municipal addresses as properties of architectural and/or historical value or interest under Part IV of The Ontario Heritage Act, Chapter 122.

- a) Part of Lot 16, Concession 3, R.F.  
Nepean, Ontario.

The designation is to include:

- (i) the exterior, excluding a frame and a block addition at the rear, ✓  
(ii) sufficient property to protect the siting of the building.

Reasons for Proposed Designation:

City of Nepean: Jockvale School House ✓  
(SS #10, Nepean)

The Jockvale School House is one of three early school buildings still remaining in the City of Nepean. The two room school built in 1906 is a decorative red brick veneer on a stone foundation. Architecturally the building represents a fine example of school architecture dating from the turn of the century.

The school which operated until 1965, is now owned by the City of Nepean and used for community purposes.

- b) S½ of Lot 26, Concession 1, R.F. ✓  
Nepean, Ontario.

The designation is to include:

- (i) the exterior excluding the frame addition at the rear,  
(ii) the total property associated with the building.

Reasons for Proposed Designation:

City of Nepean: Merivale School House  
(SS #13, Nepean)

The Merivale School is one of three early school buildings ✓  
remaining in the City of Nepean.


The present limestone structure which replaced three earlier schoolhouses of log and of frame was built between 1895 and 1900. Partially destroyed by fire five years later, it was rebuilt in its present form. The

building has cumbered windows with carving at the top, an unusual round window over the front door and an attractive spire and represents a fine example of school architecture dating from the turn of the century.

The land was acquired by the Public School Trustees of Section Number Thirteen of the Township of Nepean from John and Sarah McFarlane and Robert and Margaret Reid in 1869. In 1953 the property was sold to the trustees of the Merivale Loyal Orange Lodge No. 85 and has since been used as an Orange Hall.

Notice of objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts may be served on the Clerk of the City of Nepean before the 5th day of February, 1982.
