THE CORPORATION OF THE TOWNSHIP OF BLANDFORD-BLENHEIM

BY-LAW NO. 655-86

BY-LAW TO DESIGNATE WOLVERTON HALL IN THE TOWNSHIP OF BLANDFORD-BLENHEIM TO BE OF HISTORIC AND ARCHITECTURAL VALUE OR INTEREST.

WHEREAS Section 29 of the Ontario Heritage Act, R.S.O. 1980, C. 337, authorizes Council of a municipality to designate property within the municipality to be of historic or architectural value or interest; -

AND WHEREAS Council for the Corporation of the Township of Blandford-Blenheim deems it desirable to designate Wolverton Hall to be of historic and architectural value or interest;

AND WHEREAS the Clerk of the Township of Blandford-Blenheim has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of The Ontario Heritage Act, R.S.O. 1980, C. 337;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of The Ontario Heritage Act, R.S.O. 1980, C. 337.

- 1. The property described in Schedule "A" attached hereto is hereby designated to be of historic and architectural value and interest.
- 2. Section 33(1) of The Ontario Heritage Act, R.S.O. 1980, C. 337 shall apply only to the following:
 - (a) glass cupola on the roof, double veranda on the north side of house, painted glass around front entrance.
 - (b) circular staircase, exterior brickwork.
- 3. This By-law shall come into effect on the final passing thereof by the Council of the Corporation of the Township of Blandford-Blenheim.
