## TOWNSHIP OF COLLINGWOOD

## NOTICE

TAKE NOTICE that pursuant to the provisions of the Ontario Heritage Act R.S.O. 1980, the Corporation of the Township of Collingwood intends by by-law to designate the Clarksburg School on Hillcrest Drive as a building of historical or architectural interest. Said building being situated on parts of Lots 56, 57, 58, 59 and 60, Plan 113 in the Police Village of Clarksburg.

When the school was being built, children from the then present school on Marsh Street even participated in its actual construction by each laying a brick on Columbus Day, October 12th, 1892.

The third room which was added to the west of the existing structure was built in 1963 and now serves as the Council Chambers.

The building itself will soon be 100 years old and was used for school purposes until 1980.

Architecturally it is a building typical of those built in that era and historically has served as the site of formal education for local residents since before the turn of the century.

The Township of Collingwood acquired the land and buildings from the Grey County Board of Education in the summer of 1982 and has since undertaken extensive repairs and renovations to reduce energy costs and to convert the interior into a functional municipal office.

The mature trees and open space will be maintained to enhance and preserve the beauty of the site and the building itself, as a municipal office, should serve the public for many years to come and is worthy of restoration, repair and preservation.

Any person who wishes to object to the proposed designation, shall within 30 days of the publication herein, serve on the Clerk of the Township, a Notice of Objection, setting out the objections and all relevant facts thereto.
