



NOTICE OF INTENTION TO DESIGNATE

Take Notice that the Council of the Town of Carleton Place  
intends to designate a portion of the residence at the following  
address as property of historical and architectural value or  
interest under Part IV of the Ontario Heritage Act, R.S.O. 1990,  
Chapter O.18.

15 High Street

Legal Description

That tract of land described as Lot 14, Registered Plan 276,  
Section A in the Town of Carleton Place in the County of Lanark  
locally known as 15 High Street. The residence is currently owned  
by a [REDACTED] and [REDACTED].

Reason for the Proposed Designation

Historical Interest

The residence on the property was built in the 1830's for a John  
Bell (son of Reverend Bell of Perth, Ontario) by Mr. Henry  
Wilson. The Bell family were prominent business people in the  
early history of Carleton Place. The residence has also been the  
home of several other notable families since originally  
constructed.

Architectural Interest

The residence, which is one of the oldest in Carleton Place, is  
constructed of rough hewn stone and is a fine example of the  
Georgian style of architecture, prominent during the 19th  
century. Structurally, the residence has the original roofline,  
soffit and fascia. The front door of the residence also displays  
a semi elliptical fanlight and sidelights. Adjacent to the  
residence are two architecturally significant stone hedges  
(walls) on the east and south side of the property.

The designation

It is proposed to designate by municipal by-law, the exterior  
stone walls of the south, east and west side of the residence as  
well as the existing stone hedges (walls) on the east and south  
side of the property. Note: The designation as proposed does not  
affect a planned addition to the north side of the residence or  
sympathetic improvements to the balance of the house.

Any person may, within thirty days of the publication of this notice, send by registered mail or deliver by hand to the Clerk of the Town of Carleton Place notice of his or her objection to the proposed designation together with a statement of the reason or reasons for the objection and all relevant facts. If such a notice of objection is received, the Council of the Town of Carleton Place will refer the matter to the Conservation Review Board for a Hearing.
