## THE CORPORATION OF THE TOWNSHIP OF DELHI

## BY-LAW NO. 36-93

A BY-LAW TO REPEAL BY-LAW 27-89, BEING A BY-LAW TO DESIGNATE PART LOT 46, LOT 47, CONCESSION 2, S.T.R.

WHEREAS By-law No. 27-89 designated the property municipally known as Part of Lot 46 and the whole of Lot 47, Concession 2, S.T.R., geographic Township of Middleton, County of Norfolk, now in the Township of Delhi, Regional Municipality of Haldimand-Norfolk;

AND WHEREAS, the Ontario Heritage Act, R.S.O. 1990, as amended, Chapter 0.18, Section 32(1) states that an owner of property designated under this part may apply to the Council of the municipality in which the property is situate to repeal the by-law or part thereof designating the property;

AND WHEREAS the owner of the property has requested and applied to the Council of the municipality to repeal the designating by-law;

AND WHEREAS the Council has sought and received consultation from its Local Architectural Conservation Advisory Committee;

AND WHEREAS the Council has consented to pass a by-law repealing By-law No. 27-89;

NOW THEREFORE the Council of the Corporation of the Township of Delhi hereby enacts as follows:

That By-law 27-89 be hereby repealed.

- That a copy of this by-law shall be registered against the property described in Schedule "A" hereto in the proper Land Registry Office at Simcoe, Ontario.
- That the Clerk is hereby authorized to cause a copy of this 3. by-law to be served on the owner of the property described in Schedule "A" and on the Ontario Heritage Foundation and to cause notice of this By-law to be published in the same newspaper having general circulation in the municipality.
