THE CORPORATION OF THE TOWNSHIP OF NORFOLK
BY-LAW NUMBER 1436-94

A By-Law to designate the [REDACTED] Residence, Lands and Buildings being Block 45, R.P. 16B, Geographic Village of Port Rowan, in the Township of Norfolk, in the Regional Municipality of Haldimand-Norfolk, as being of architectural and historical value or interest.

WHEREAS The Ontario Heritage Act, R.S.O. 1990, Chapter 0.18 authorizes the Council of a Municipality to enact By-Laws to designate real property, including all buildings and structures thereof to be of architectural and historical value or interest.

AND WHEREAS notice of intention to designate the Miklovich Residence being Block 45, R.P. 16B, Geographic Village of Port Rowan, now in the Township of Norfolk, Regional Municipality of Haldimand-Norfolk was served on the Township of Norfolk Local Architectural Conservation Advisory Committee and such notice of intention was published in the Simcoe Reformer, a newspaper having general circulation in the municipality, once a week for each of three consecutive weeks;

AND WHEREAS the reasons for designation are set out in Schedule "B" hereto.

AND WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the Municipality;

NOW THEREFORE the Council of the Corporation of the Township of Norfolk enacts as follows:


1. There is designated as being of architectural and historical value or interest the real property known as the Miklovich Residence being Block 45, R.P. 16B, Geographic Village of Port Rowan, more particularly described on Schedule "A" attached hereto.
2. The Clerk-Administrator is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule "A" hereto in the Land Registry Office at Simcoe, Ontario.
3. The Clerk-Administrator is hereby authorized to cause a copy of this By-law to be served on the owner of the property described in Schedule "A" hereto and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the Simcoe Reformer once a week for each of three consecutive weeks.



Designation of the home of [REDACTED] part Lot 18, Con. 1 Township of Norfolk (former Township of South Walsingham) under the Ontario Heritage Act 1974, Section IV is recommended by the Local Architectural Conservation Advisory Committee. The following features should be noted for their architectural and historical significance.

two storey red brown brick

8 over 8 windows - nine in the house

two quarter round windows

floors and woodwork white or red pine

brick interior walls

chimney rises from basement, includes a fireplace in living room and extends through interior of house

bricks in south wall read "Price 1861", which may indicate name of builder or mason and year built

house may have served as an inn
