NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of the Corporation of the Township of Delhi intends to designate the property including lands and buildings at the following municipal address as a property of architectural and/or historical value or interest under Part IV of the Ontario Heritage Act, R.S.O. 1990, as amended, Chapter 0.18:

Any person may, within thirty days of the first publication of this notice send by registered mail, or deliver to the Clerk of the Township of Delhi notice of his/her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts. If such a Notice of Objection is received, the Council of the Corporation of the Township of Delhi shall refer the matter to the Conservation Review Board for a hearing. The reasons for designation are available by contacting the undersigned.
