## NOTICE OF INTENTION

## TO DESIGNATE THE WALSH/BRINKER HOUSE

**TAKE NOTICE THAT,** the Council of The Corporation of Norfolk County intends to designate the Walsh/Brinker house located on Part Lot 1, 8, 13-14, Block 113, Plan 182, municipally known as 48 Stanley Street, Simcoe, Ontario, within Norfolk County, as being of cultural heritage value or interest.

The house dates from the 1860's and is recognized to be of historical significance as it features examples of varied, early brickwork and the Loyalist and Regency styles. The history of the area is also associated with the extended family of prominent citizen Thomas Walsh. Evidence of its early construction is seen in the Flemish and garden wall brick bonding on the front elevations, the large square headed windows with flush brick arches and its overall symmetry. The early Regency style is seen in the front door with its small and larger paned sidelights and transom. The back addition and Victorian veranda add interest and appeal.

Further information respecting the proposed designation is available at the Clerk's Office, Norfolk County Administration Building, 50 Colborne Street South, Simcoe.

Any person who objects to the proposed designation may serve on the Clerk of Norfolk County not later than the 19th day of January, 2009 a notice of objection setting out the reason for objection and all relevant facts.
