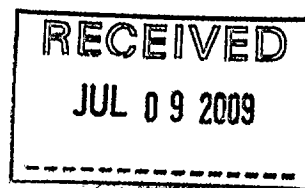

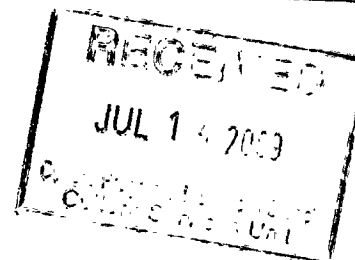

**BY-LAW NO. 2009-129**

OF

***The Corporation of Norfolk County***

**BEING A BY-LAW TO AMEND NORFOLK COUNTY BY-LAW 2006-192, WHICH DESIGNATES THE PROPERTY KNOWN AS THE MUNRO/MOUND RESIDENCE DESCRIBED AS PART LOT 14, CONCESSION 4, GEOGRAPHIC TOWNSHIP OF CHARLOTTEVILLE, NORFOLK COUNTY, UNDER THE HERITAGE ACT.**

**WHEREAS** Norfolk County By-Law 2006-192 was passed on August 29<sup>th</sup>, 2006 and registered in the Norfolk Land Registry Office (No. 37) on September 6<sup>th</sup>, 2009 as Instrument No. 0604161, which designated the Munro/Mound Residence under the Heritage Act;

**AND WHEREAS** the owner of the Munro/Mound Residence has given consent to a recommendation made by the Norfolk Heritage Committee to amend the property's heritage attributes by including the additional architectural feature of the authentic cedar shingle roof;

**AND WHEREAS** Notice of the proposed Heritage Designation Amendment was served on the property owner as required under the Ontario Heritage Act;

**AND WHEREAS** Norfolk County Council deems it necessary to amend Norfolk County By-Law 2006-192 to include the additional architectural feature of the authentic cedar shingle roof on the Munro/Mound Residence located on Part Lot 14, Concession 4, Geographic Township of Charlotteville, described as Part 1, Plan 37R-4671, being all of P.I.N. 50199-0110 (LT).

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF NORFOLK COUNTY HEREBY ENACTS AS FOLLOWS:**

1. That Norfolk County By-Law 2006-192, Schedule "A" – Reasons for Designation, is hereby amended by adding the following heritage attribute thereto:

"Authentic Cedar Shingle Roof"

2. That this By-Law shall be registered in the Land Registry Office of the Division of Norfolk (No. 37).

3. That the effective date of this By-Law shall be the date of final passage thereof.
