

**Re: Amendment of Robertson/Mels Heritage Designating By-Law**

Please be advised that an amendment to the above-noted Heritage Designating By-Law has been necessary. It was recently discovered that former Township of Delhi By-Law 35-91, adopted on May 6, 1991 and registered in the Norfolk Land Registry Office on May 10, 1991 as Instrument No. NR479086, incorrectly referenced the heritage designation to a total of nine properties. The designation should have been applied to only the Robertson/Mels residence located on Part Lot 11, Concession 7, Geographic Township of Windham, Part 2, Plan 37R-8591, Norfolk County, PIN 50261-0260(LT).

Norfolk County Council deemed it necessary to amend the Designating By-Law in order to correct the legal description of the heritage property. In accordance with the Ontario Heritage Act, affected property owners of the proposed amendment were notified and no objections were filed with the Clerk.

To facilitate the above-noted Amendment, By-Law 35-91 was repealed in its entirety by Norfolk County By-Law 2009-05 and a new Norfolk County Designating By-Law 2009-06, for the Robertson/Mels Residence only, was adopted. By-Laws 2009-05 and 2009-06, were registered in the Norfolk Land Registry Office on January 19, 2009 as Instruments NK20922 and NK20924 respectively.

**BY-LAW NO. 2009-05**

OF

***The Corporation of Norfolk County***

**BEING A BY-LAW TO REPEAL FORMER TOWNSHIP OF DELHI BY-LAW 35-91, WHICH DESIGNATES THE PROPERTY KNOWN MUNICIPALLY AS PART LOT 10, PART LOT 11, CONCESSION 7, GEOGRAPHIC TOWNSHIP OF WINDHAM, NORFOLK COUNTY, UNDER THE HERITAGE ACT.**

**WHEREAS** former Township of Delhi By-Law 35-91 was passed on May 6<sup>th</sup>, 1991 and registered in the Norfolk Land Registry Office (No. 37) on May 10<sup>th</sup>, 1991 as Instrument No. NR479086;

**AND WHEREAS** an incorrect legal description was included in former Township of Delhi By-Law 35-91 which has incorrectly referenced the heritage designation to a total of nine properties;

**AND WHEREAS** the heritage designation should only be applied to the Robertson/Mels residence located on the property described as Part Lot 11, Concession 7, Geographic Township of Windham, Part 2, Plan 37R-8591, Norfolk County, PIN 50261-0260(LT);

**AND WHEREAS** it is deemed necessary to repeal former Township of Delhi By-Law 35-91 in order to exclude properties designated in error and to prepare a new By-Law 2009-06 to designate the Heritage Designation of the Robertson/Mels Residence located on Part Lot 11, Concession 7, Geographic Township of Windham, Part 2, Plan 37R-8591, Norfolk County, PIN 50261-0260 (LT).

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF NORFOLK COUNTY HEREBY ENACTS AS FOLLOWS:**

1. That former Township of Delhi By-Law 35-91, which applies to the following properties, is hereby repealed in its entirety;

Part Lot 11, Concession 7 Windham, Part 1, Plan 37R-4348, Norfolk County, PIN 50261-0249(LT);  
Part Lot 11, Concession 7 Windham, Part 2, Plan 37R-4348, Norfolk County, PIN 50261-0247(LT);  
Part Lot 11, Concession 7 Windham, Part 3, Plan 37R-4348, Norfolk County, PIN 50261-0246(LT);  
Part Lot 11, Concession 7 Windham, Part 4, Plan 37R-4348, Norfolk County, PIN 50261-0245(LT);  
Part Lot 11, Concession 7 Windham, Part 1, Plan 37R-5773, Norfolk County, PIN 50261-0251(LT);  
Part Lots 10-11, Concession 7 Windham, as in NR581416, Norfolk County, PIN 50261-0259 (LT);  
Part Lot 11, Concession 7 Windham, Part 1, Plan 37R-5772, Norfolk County, PIN 50261-0250(LT);  
Part Lot 11, Concession 7 Windham, Part 1, Plan 37R-8591, Norfolk County, PIN 50261-0261(LT);  
Part Lot 11, Concession 7, Windham, Part 2, 37R-8591, Norfolk County, PIN 50261-0260 (LT).

2. That this By-Law shall be registered in the Land Registry Office of the Division of Norfolk (No. 37).
3. That the effective date of this By-Law shall be the date of final passage thereof.



**EXPLANATORY NOTE TO BY-LAW 2009-05**

The former Township of Delhi By-Law 35-91 which was adopted on May 6<sup>th</sup>, 1991 and registered in the Norfolk Land Registry Office (No. 37) on May 10<sup>th</sup>, 1991 as Instrument No. NR479086, is being repealed to facilitate some necessary amendments.

The legal description of the property designated under former Township of Delhi By-Law 35-91 should have excluded Parts 1, 2, 3 and 4 on Plan 37R-4348, Norfolk County, which was registered prior to the Designation.

In addition, as the By-Law was brought forward in error under the new Land Titles System to four additional PINS, that the By-Law also be amended to exclude the following PINS: 50261-0251(LT), 50261-0259(LT), 50261-0261(LT) and 50261-0250(LT).
