BY-LAW NO. 2010-92

OF

The Corporation of Norfolk County

BEING A BY-LAW TO AMEND BY-LAW 33-90 OF THE FORMER CITY OF NANTICOKE TO DESIGNATE THE PROPERTY LOCATED AT LOT 1, PART LOTS 2, 8 & 9, BLOCK N, PLAN 19B, NORFOLK COUNTY, AS A PROPERTY OF HISTORICAL AND ARCHITECTURAL VALUE. (GREEN/BRUYN RESIDENCE)

WHEREAS the former City of Nanticoke By-Law 33-90 was passed on April 3, 1990 and registered in the Norfolk Land Registry Office (No.37) on May 3, 1990 as Instrument No. 470441 which designated the Green/Bruyn Residence under the Ontario Heritage Act;

AND WHEREAS the owner of the Green/Bruyn Residence has given consent to a recommendation made by the Norfolk Heritage Committee to amend the property's heritage attributes by deleting all references to the exterior windows of the residence;

AND WHEREAS written notice of the proposed Heritage Designation Amendment has been given to the property owner as required under the Ontario Heritage Act and no notice of objection has been received by the Clerk within 30 days of receiving the said notice;

AND WHEREAS Norfolk County Council deems it necessary to amend former City of Nanticoke By-Law 33-90 to delete all references to the exterior windows of the Green/Bruyn Residence located on Lot 1, Part Lots 2, 8 and 9, Block N, Plan 19B, Norfolk County, being P.I.N. 50280-0176 (LT).

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF NORFOLK COUNTY HEREBY ENACTS AS FOLLOWS:

1. That former City of Nanticoke By-Law 33-90, Schedule "A" – Reasons for Designation under the Ontario Heritage Act, is hereby amended by deleting all references to the exterior windows of the Green/Bruyn Residence.
2. That the Clerk be authorized and instructed to register a copy of this By-Law in the Registry Office of the Land Registry Division of Norfolk;
3. THAT the Clerk, or his/her designate, is hereby authorized to amend the parcel designation noted in this By-Law, if necessary, upon registration of this By-Law.

4. That the effective date of this By-Law shall be the date of final passage thereof.




