TAKE NOTICE THAT the Council of the Corporation of the Town of Rockland intends to designate the properties, including lands and buildings, at the following municipal addresses as properties of historical and architectural value or interest under Part IV of the Ontario Heritage Act, 1974, R.S.O. 1990, Chapter 0.18.

**THE FORMER BAPTIST CHURCH
(today known as the Rocktown Bar)
1587 Laurier Street**

Part of Lot 19, South side of Laurier Street
Andrew Bell Plan, February 12, 1908, County of Russell and
Part of Lot 26, Concession 1 (O.S.)
Township of Clarence, County of Russell

REASONS FOR THE PROPOSED DESIGNATION

The building was erected in 1890. It was the first church erected within the boundaries of the municipality servicing the English-speaking residents. The heads of the Edwards Company have actively participated in the realization of this former church. The use

In addition to its historical value, the former Baptist Church is also architecturally significant. The architecture is of Renouveau Classique style and the framework is composed of wood that was manufactured at the former local sawmill. The building features the following: a steeply pitched gable tin roof composed of three main surfaces (one rear and two lateral), red clay brick bounded by red tinted mortar and a carved stone foundation hidden behind a layer of cement and a front wall endowed with a stained glass bull's-eye window.

Part of Lot 18 and 20, south side of Main Street

REASONS FOR THE PROPOSED DESIGNATION

The building was erected in 1880. It was the first public school erected within the boundaries of the municipality servicing the English-speaking residents. The heads of the Edwards Company have actively participated in the realization of this former school. The use of the building as a school continued until 1966.

In addition to its historical value, the former Public School is also architecturally significant. The architecture is of Renouveau Classique Style and the framework is composed of wood that was manufactured at the former local sawmill. The building features the following: a tin, medium pitch, gable roof with gable end to the street, red clay brick bounded by red tinted mortar and a carved stone foundation and a front wall endowed with a wooded open porch and a bull's-eye window.

**THE MUNICIPAL LIBRARY
(FORMELY THE POST OFFICE)**
2085 Laurier Street
Parts of Lots 2 and 3, South side of Laurier Street
Andrew Bell Plan, November 06, 1908, County of Russell

REASONS FOR THE PROPOSED DESIGNATION

The building was erected in 1927. Originally the building housed the Town's Post Office.

In addition to its historical value, the former Post Office is also architecturally significant. It is a building inspired by the Chateau Style and by the Second Empire Style. The building features the following: a four surface tin panel truncated hip roof, wall dormers, oriel windows, a front wall with a projected entrance and red clay brick bounded by red tinted mortar. The inside of the building features original elements of decor such as the staircase, the walls, the ceilings, the floors, the doors, the moldings, the trims, the woodworks and the finish.

Any person may, within thirty days of the first publication of this notice, send by registered mail or deliver to the Clerk of the Corporation of the Town of Rockland a notice of his or her objection to the proposed designations along with a statement of the reasons for the objection and all relevant facts.
