CORPORATION OF THE TOWN OF PARKHILL

BY-LAW NO. 89-H-3

A BY-LAW TO DESIGNATE THE PROPERTY KNOWN MUNICIPALLY AS TARA HALL - 108 MAIN STREET PARKHILL AS BEING OF ARCHITECTURAL AND HISTORICAL VALUE OR INTEREST.

WHEREAS section 29 of The Ontario Heritage Act, 1974 authorizes the Council of a municipality to enact By-laws to designate real property, including all building and structures thereon, to be of architectural or historic value or interest; and

WHEREAS the Council of the Corporation of the Town of Parkhill has caused to be served on the owners of the lands and premises known as Tara Hall at 108 Main Street Parkhill and upon the Ontario Heritage Foundation, notice of intention to so designate the aforesaid real property and has caused such notice of intention to be published in the same newspaper having general circulation in the municipality once for each of the three consecutive weeks; and


WHEREAS no notice of objection to the proposed designation has been served on the Clerk of the municipality;


THEREFORE the Council of the Corporation of the Town of Parkhill enacts as follows:

1. There is designated as being of architectural and historical value or interest the real property known as Tara Hall at, 108 Main Street Parkhill , more particularly described in schedule A hereto.
2. The areas of the residence to be designated are set out in Schedule "B" hereto.
3. The municipal solicitor is hereby authorized to cause a copy of this By-law to be registered against the property described in Schedule A hereto in the proper land registry office.
4. The Clerk is hereby authorized to cause a copy of this By-law to be served on the owner of the aforesaid property and on the Ontario Heritage Foundation and to cause notice of the passing of this By-law to be published in the same newspaper having general circulation in the municipality once for each of three consecutive weeks.

READ A THIRD TIME AND FINALLY PASSED THIS 20th DAY OF FEBRUARY 1989 A.D.

AREAS OF RESIDENCE TO BE DESIGNATED

Exterior: -Brickwork, including chimneys
-Roof
-Windows, and doors
-Front entrance stairway

Interior -Plaster work-ceilings only, stair archway
-Woodwork (main floor except kitchen)
-Fireplaces (except kitchen)
-Front staircase
-Front Entrance interior doors
-Stained Glass windows
