THE CORPORATION OF THE TOWNSHIP OF NORTH DUMFRIES

BY-LAW NO. 1240-90

BY-LAW TO DESIGNATE THE STRUCTURE LOCATED AT MUNICIPAL PLAN LOT 5 TO LOT 9, PART OF LOT 10, PLAN 673, LOT 48, TOWNSHIP OF NORTH DUMFRIES, TO BE OF A HISTORIC AND ARCHITECTURAL VALUE AND INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O.

1980 authorizes Council of a Municipality to designate property
within the Municipality to be of historic value of interest;

AND WHEREAS Council for The Corporation of the Township of North Dumfries deems it desirable to designate the building familiarly known as the Ayr Public School, 105 Hall Street, Ayr, Ontario, to be of historic and architectural value and interest;

AND WHEREAS the Clerk of the Township of North Dumfries has caused Notice of Intention to Designate to be given in accordance with Section 29(3) of The Ontario Heritage Act, R.S.O. 1980;

AND WHEREAS no Notice of Objection has been served on the Clerk within the meaning of Section 29(5) of The Ontario Heritage Act, R.S.O. 1980;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF NORTH DUMFRIES ENACTS AS FOLLOWS:

- 1. The property described in Schedule "A" attached hereto is hereby designated to be of historic and architectural value and interest.
- 2. Section 33 of The Ontario Heritage Act, R.S.O. 1980 shall apply only to the ornametal cupola built to house the school's bell, including the weather vane and the large inscription of the west wall of the frontispiece, reading "Public School 1890".

This By-law shall come into effect on the final passing thereof by the Council of The Corporation of the Township of North Dumfries.


