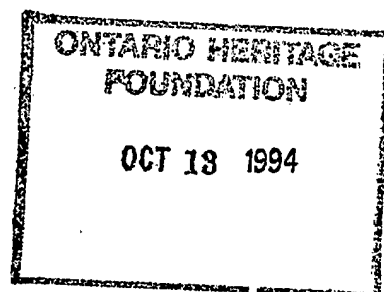

**TAKE NOTICE** that the Council of the Corporation of the Township of North Dumfries intends to designate the property at the following municipal address as a property of historical and architectural significance under Part IV of the Ontario Heritage R.S.O. 1990, Chapter O.18.

**Plan Mun Lot 4 N/S Stanley St., 92 Stanley St., Ayr, ON**

The proposed designation recognizes the historical and architectural significance of the subject property.

The one storey Library represents an important example of community philanthropy financed by Andrew Carnegie prominent at the turn of the century. Evidence shows the building to be constructed in 1911. It is architecturally significant because of its classicism style and design which represents the shift in North American architecture at the turn of the century.

Designation is intended to cover the exterior of the building.

Any person may, within thirty days of the first publication of this Notice, send by registered mail or deliver to the Clerk of the Township of North Dumfries, notice of his or her objection to the proposed designation, together with a statement of the reasons of the objection and all relevant facts. If such a notice of objection is received, the Council of the Township of North Dumfries shall refer the matter to the Conservation Review Board for a hearing.
