

### NOTICE OF INTENTION TO DESIGNATE

Take Notice that the Council of the Corporation of the Township of North Dumfries intends to designate the property at the following municipal address as a property of historical and architectural significance under Part IV of the Ontario Heritage RSO 1990, Chapter 0.18.

House of Jane and Lorne Foerter  
RR #1  
Highway #8  
Cambridge, Ontario

PT LOT 2, CONCESSION #9

The proposed designation recognizes the historical and architectural significance of the subject property.

The one and one half storey limestone house, circa 1865, is representative of Gothic Style architecture, common in the Township. The house was built by the Bond family and the property remained in the family for over one hundred years. The front façade is constructed of course cut limestone and the corners and windows are accented with limestone quoins and voussoirs. The centre gable window is pointed and also surrounded with quoins and voussoirs. All of the windows are 6 over 6 double hung. The original stone threshold remains at the front entrance to the home.

Designation is intended to cover the front wall and entrance including the stone threshold.

Any person may, within thirty (30) days of the first publication of this Notice, send by registered mail or deliver to the Clerk of the Township of North Dumfries, notice of his or her objection to the proposed designation, together with a statement of the reasons of the objection and all relevant facts. If such a notice of objection is received, the Council of the Township of North Dumfries shall refer the matter to the Conservation Review Board for a hearing.
