**TAKE NOTICE that the Council of The Corporation of the Township of North Dumfries
intends to designate the property at the following municipal address as a property of
historical and architectural significance under Part IV of the Ontario Heritage Act,
R.S.O. 1990, Chapter O.18.**

**Part of Gore Lot Letter J, otherwise known as
Lot Letter J, Concession 10, lying South of
the right-of-way of the lands of the Canadian
Pacific Railway Company, in the Township of
North Dumfries (formerly in the Township of
Beverly), in the Regional Municipality of
Waterloo.**

**The proposed designation recognizes the historical and architectural significance of the
subject property.**

**The two storey limestone house, circa 1880, is an example of a traditional limestone
farmhouse. Its two storey, rectangular construction was the typical structure for
buildings built in the period of time in which the house was built. On both long sides
of the house are windows that are nearly mirror images of each other.**

Designation is to include the limestone exterior of the building, excluding the addition.

**Any person may, within thirty days of the first publication of this Notice, send by
registered mail or deliver to the Clerk of the Township of North Dumfries, notice of his
or her objection to the proposed designation, together with a statement of the reasons
for the objection and all relevant facts. If such a notice of objection is received, the
Council of the Township of North Dumfries shall refer the matter to the Conservation
Review Board for a hearing.**
