
We enclose herewith a copy of a Resolution of North Dumfries Township Council expressing their intent to designate a property within the Municipality together with the Notice of Intention to Designate.

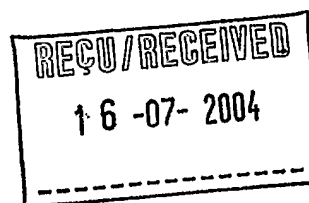

NOTICE OF INTENTION TO DESIGNATE

TAKE NOTICE that the Council of The Corporation of the Township of North Dumfries intends to designate the property at the following municipal address as a property of historical and architectural significance under Part IV of the Ontario Heritage Act, R.S.O. 1990, Chapter O/18.

1720 Spragues Road, Township of North Dumfries
Part Lots 19-20 Concession 8, North Dumfries as
in 1193280 lying North of Part 1, 58R-12868;
North Dumfries. (PIN 03855-0097)

The proposed designation recognizes the historical and architectural significance of the subject property.

The one storey farm outbuilding is one of the few remaining stone farm structures in the Township of North Dumfries from the mid 19th century. It is unique in the Township in that it is the only octagonal stone farm building. It served as a rural blackshop in the latter part of the 19th century and early 20th century. As such, it is a good example of an agricultural industrial building which was part of a complex of farm buildings on the farmstead, as well as a valuable part of the wider agricultural community.

The building is a free-standing, octagonal, rubble stone structure capped by a self-supporting, eight-sided wood roof. As well as the above, the designation includes the windows, the eaves, and the original cobblestone floor.

Any person may, within thirty days of the first publication of this Notice, send by registered mail or deliver to the Clerk of the Township of North Dumfries, notice of his or her objection to the proposed designation, together with a statement of the reasons for the objection and all relevant facts. If such a notice of objection is received, the Council of the Township of North Dumfries shall refer the matter to the Conservation Review Board for a hearing.
