

THE CORPORATION OF THE TOWN OF BRACEBRIDGE

BY-LAW NO. 2003-111

BEING A BY-LAW TO DESIGNATE A PORTION OF THE PROPERTY LOCATED AT 23 DOMINION STREET, ONTARIO AS BEING OF HISTORIC OR ARCHITECTURAL VALUE OR INTEREST.

WHEREAS Section 29 of The Ontario Heritage Act, R.S.O. 1990, c. O.18, permits a local municipality to pass a by-law to designate property within the municipality to be of cultural heritage value or interest;

AND WHEREAS the Council of the Corporation wishes to designate the hose tower, which formed part of the original town hall and fire hall located on Part of Lot 5, East Dominion Street, Registered Plan 1 and Part of Lot A, East Dominion Street, Registered Plan 8 from 1881 to 1957 and has become a landmark of some significance;

AND WHEREAS no notice of objection to the proposed designation has been served upon the Clerk of the said Municipality in response to the published notice of intention;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF BRACEBRIDGE ENACTS AS FOLLOWS:


1. That the hose tower forming part of the original town hall and fire hall building located on Part of Lot 5, East Dominion Street, Registered Plan 1 and Part of Lot A, East Dominion Street, Registered Plan 8, Town of Bracebridge be designated as being of historic and/or architectural value or interest.
2. That the Municipal Solicitor is hereby authorized to have this by-law registered against the property as shown in heavy outline on the sketch attached to this by-law as Schedule "A".
3. The Municipal Clerk is hereby authorized to cause a copy of this by-law to be served upon the owner of the said property and on the Ontario Heritage Foundation and to publish notice of the by-law in a newspaper having general circulation in the municipality






