

PUBLIC NOTICE

TAKE NOTICE THAT the Council of The Corporation of the City of Brampton proposes to designate, as a property of historical or architectural value or interest, pursuant to Section 29 of The Ontario Heritage Act, 1974, the property known as the Davidson house, which is located on the east side of Second Line West, south of Steeles Avenue, in the City of Brampton and more particularly described as follows:

The land situated in the City of Brampton, in the Regional Municipality of Peel (formerly in the Township of Toronto, in the County of Peel), being the part of the west half of Lot 13, Concession 2, West of Hurontario Street, designated as Part 1 on a reference plan in the Land Registry Office for the Registry Division of Peel (No. 43) as number 43R-9537.

Reference Plan 43R-9537 may be viewed at the office of the Clerk during regular office hours.

Reasons for the Proposed Designation:

The Davidson's' House: Meadowvale

William Elliott built this house in 1845 in the <sup>Regency</sup> Regent Cottage Style popular in Peel at that time. Its five bay facade has a squatty appearance since the upper storey is concealed by the sloping roof. Originally a verandah ran the total length of the house but it has been reduced to three bays. An engraving in the Peel Atlas of 1829, illustrates the house in its original state. Although the Davidson's have extended at the back of the house, the original home has been carefully maintained. Interesting features such as the series of dentils running around the roof line and the twin chimneys at each end of the roof can still be seen.
