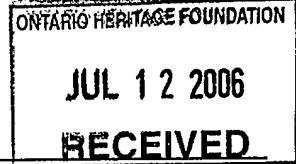

The Heritage Advisory Committee on June 27, 2006, considered the above captioned matter and recommended the following:
