To amend By-law 61-83

WHEREAS the Council of The Corporation of the City of Brampton passed By-law 61-83 to designate the Odlum-Morelli Home as a property of historical and architectural value and interest pursuant to the Ontario Heritage Act;

AND WHEREAS the lands subject to the designation under By-law 61-83 include lands now described as part of Lots 2 and 3 and part of Lucinda Court on Registered Plan 43M-724;

AND WHEREAS the Odlum-Morelli Home is located entirely on part of Lot 2, Registered Plan 43M-724;

AND WHEREAS it is unnecessary for the heritage designation to apply to part of Lot 3 or part of Lucinda Court on Registered Plan 43M-724;

AND WHEREAS the Owners of Lot 2, Registered Plan 43M-724 have requested that By-law 61-83 be amended to refer to the home as the Odlum Home;

AND WHEREAS the Brampton Local Architectural Conservation Advisory Committee, known as the Brampton Heritage Board, is of the opinion that the enactment of this by-law will not affect the reasons for the designation of the subject property;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- 1. By-law 61-83 is hereby amended by changing all references to the "Odlum-Morelli Home" contained therein to the "Odlum Home".
- 2. By-law 61-83 is hereby repealed only as it relates to the lands described as Lot 3 and Lucinda Court according to Registered Plan 43M-724.

READ a FIRST, SECOND, and THIRD TIME, and PASSED in Open Council this 27th day of November, 1989.
